**GAZETTED ORDERS OF PEMBANGUNAN SUMBER MANUSIA BERHAD
(AMENDMENT OF FIRST SCHEDULE) ORDER 2021**

- 1) This Advisory Note to ACEM Members is in relation to the above Order.
- 2) We have been informed that a number of our Members, but not all, have received letters from PMSB compelling them to register with PMSB under the above Order.
- 3) However, ACEM has received a letter from PMSB (91)/PMSB/1/2/44 Klt.3 dated 30 September 2005 exempting our industry and engineering consulting firms from registering. (Copy attached below)
- 4) ACEM has not received any notice that that exemption has been rescinded and therefore takes the position that it is still valid.
- 5) ACEM has requested for a meeting with the YB Minister of Human Resources to discuss this issue.
- 6) In the meantime, ACEM advises all members who have received the PMSB letter to reply indicating that action to register or not will depend on the outcome of ACEM's meeting with the YB Minister. Attach the PMSB exemption letter too.

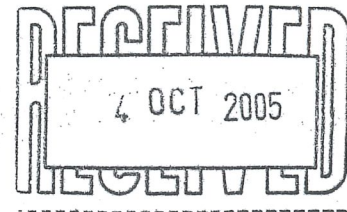



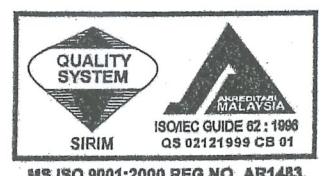
