EXTRACTS FROM THE ARTICLES OF ASSOCIATION

DEFINITION OF A CONSULTING ENGINEER

A person who is a Professional Engineer (PE) with Practising Certificate (PC) currently registered with BEM providing Professional Engineering Services who is a Sole Proprietor, Partner, Director or Shareholder of an ECP currently registered with BEM.

DEFINITION OF ENGINEERING CONSULTANCY PRACTICE (ECP)

A sole proprietorship, partnership or body corporate providing professional engineering services currently registered with BEM.

QUALIFICATIONS OF MEMBERS

8. (1) No person shall be qualified for Membership of the Association unless he is either -

- (a) a sole proprietor of an ECP
- (b) a partner in an ECP
- (c) a Director in a Body Corporate ECP
- (d) a Shareholder of a Body Corporate ECP who is a Professional Engineer or Professional Engineer with Practising Certificate
- (e) a Consultant of an ECP
- (2) No person shall be elected to Membership of the Association unless he shall be of such standing and experience as in the opinion of the Council qualifies him to be a Member of the Association.

Provided that Council shall have absolute discretion to grant and review from time to time exemption to any person from any or all the above provisions if Council deems that such exemption is in the interest of the Nation or the Association.
