EXTRACTS FROM THE ARTICLES OF ASSOCIATION

8. (5) Life Member

- (a) The Council may on the retirement from practice of any Member of the Association and provided that he is not otherwise ineligible for Membership, elect him as a Life Member of the Association, with no obligation to pay any annual subscription to the Association, but may enjoy such benefits as may be determined by the Council from time to time.
 - (b) A Life Member shall have no voting rights but is entitled to participate in selected activities of the Association, as approved by the Council, at member rate charges and he may be nominated to be a member of any of the Standing Committees that may be established from time to time.
 - (c) A Life Member shall not be qualified to be elected as a member of the Council.
 - (d) A Life Member must have had a minimum of 10 years membership with the Association and must have served either on the Council or any of its Committees.
- (7) No person shall be elected as a Life Member of the Association unless he shall be of such standing and experience as in the opinion of the Council qualifies him to be a Life Member of the Association.

Provided that Council shall have absolute discretion to grant and review from time to time exemption to any person from any or all the above provisions if Council deems that such exemption is in the interest of the Nation or the Association.
